Cat Adoption/Sponsorship Application

Adoption/sponsorship of a cat or cats at The Cat Survival Trust is a convenient way of supporting the work of the Trust.

Although a certificate is issued for your chosen species, your contribution is used in our general fund towards the costs of housing, housing maintenance, licence fees, insurance fees, veterinary fees, feed and administrative costs.

The cats at the Trust include surplus and breeding stock from zoos and private collections, rescued cats from zoos and private collections which have closed, rescued cats from unlicensed collections and those which have been smuggled into the country to avoid quarantine and licence costs as well as those in transit from one collection to another, where the transfer cannot be made whilst an enclosure at the recipient zoo or collection is being completed or upgraded.

The species available for sponsorship vary from time to time as new ones are taken in or aged cats come to the end of their lives. Many of the cats taken in are quite elderly or arrive with pre-existing medical complications, so their time with us can sometimes be short. With the latter, we ensure their last days with us are as comfortable as possible.

If the species you choose is fully adopted, we will still issue a certificate for that species, but in any event, your contribution will be applied for the benefit of all the cats in our care.

Please consider completing the Gift Aid form if applicable, to enable us to reclaim the tax you will have paid as a UK taxpayer.
